Announcement Regarding the Withdrawal of Request by Shareholders to Convene an Extraordinary Shareholders' Meeting

As stated in the "Announcement Regarding Receipt of Request by Shareholders to Convene an Extraordinary Shareholders' Meeting" which was announced by LIXIL Group Corporation (hereinafter "LGC") on March 22, 2019, and the "Announcement Regarding a Filing of a Request to a Court for a Convocation of an Extraordinary Shareholders' Meeting by Shareholders" announced by LGC on April 17, 2019, LGC received a document from shareholders (hereinafter "Requesters") which requested the convocation of an extraordinary shareholders' meeting.
